We cannot secure a strong future for Ohio without prioritizing the needs of our youngest Ohioans and the families who care for them.

While Ohio has made progress in fostering a policy landscape that supports children and their families, there is still significant room for improvement. On the heels of an unprecedented pandemic that has had far-reaching, negative impacts on the health and well-being of Ohio's children and their families, it is more critical now than ever to lay a strong foundation for our young children and their families.

Our budget priorities to improve early learning and health outcomes for young children and their families include:

Increasing access to child care for working Ohioans with low incomes to support the healthy development of children and improve parental workforce participation.

Expanding access to and better connecting families with critical resources that improve the health of mothers and babies.



Improving Medicaid coverage and quality to meet the unique needs of mothers and babies.
